## THE PERFECT SACRIFICE DISCUSSION QUESTIONS

HEBREWS 10:1-18

	What does the author of Hebrews mean when he writes "the law is a shadow of the good things to come"?

	Can you think of any verses that support the validity and necessity of the best law? Consider Romans 7:712.
2	It is an incredible blessing to know that we are not under the condemnation of sin. But, the OT believers did not have such freedom of conscience. We get a glimpse of what this must have felt like when we read Psalm 51:13. This is so different from NT believers who are reminded that their sins have cast as far away as the east is from the west, and that we are to boldly approach the throne of grace. The Law had no conscience-cleaning power. The New Testament, however, declares that the blood of Christ purifies our conscience from dead works to serve the living God. These two laws seem to stand in stark contrast.
